## Instruction for Authors

### A) About the Journal

*Journal of Historical sociology* (Social Science Knowledge) is an academic Journal aimed at publishing the latest theoretical and investigative findings reported by Iranian scholars and researchers at home and abroad.

The submitting articles to this journal are required to be either original findings of researches done by scholars and investigators, or, authoritative and theoretical endeavors focused on critical analysis of a specific scientific topic.

### B) Format

It is recommended that the submitting papers, particularly research-based and empirical ones, include abstract, key words, introduction, conceptual framework, methodology, findings, discussion, conclusion, and references.

1. In addition to this general guidance, following the subsequent advices is necessary:
2. Submitted papers must be correct and well written in accordance with the Persian syntax and vocabulary and should not exceed 6500 words.
3. In the case of co-authored papers, all writers are required to sign a form indicating their willingness to publish the submitted paper and one of the writers should be named as the responsible writer.
4. Two copies of the paper and one electronic version should be sent to the journal editor.
5. Writers submitting papers to the journal should not simultaneously submit them to another journal, nor should manuscripts have been published elsewhere in substantially similar form and/or content.
6. Papers that are accepted for review will be sent out anonymously for editorial evaluation and rejected manuscripts will not be returned.
7. The name of authors and their academic positions or affiliations must be appeared below the paper title. The author's current address or his/her email must be given in a footnote on the first page. Also, any acknowledgment should be very short and be given in a footnote on the first page.
8. English and Persian abstracts should be no more than 250 words and must include the aim of paper, conceptual framework, methodology, and its main findings. At the end of the abstract some 5-8 keywords should be added.
9. References should be listed in alphabetical order according to the surname of the first author at the end of the paper, and should be cited in the text as ,e.g. (Giddens, 1996:21) .
10. Citation style should be in accordance with the examples provided subsequently.
